FINANCIAL AID POLICY STATEMENT

Spuyten Duyvil Preschool, Inc. has a limited financial aid program. The number of families who can be helped by financial aid (tuition reduction) is necessarily limited because we are a very small school and the cost must be absorbed into the budget of the private program. The school is anxious to use these resources to the best advantage.

- * To be considered for financial aid, a child must first meet the basic requirements for admission.
- * Circumstances within the family must clearly indicate that enrollment would be impossible without this aid.
- * The Board of Trustees is responsible for the selection of recipients as implemented by the Director.
- * Application for financial aid should be made at the same time as application for admission, and renewed for the second year. Decisions on financial aid for the Nursery program are made to coincide with the Nursery lottery in early March.
- * Acceptance for admission is considered separately from eligibility for financial aid.
- * A family may apply for financial aid for extended time before or after the UPK program as well. If the application is received before the Nursery lottery it will be considered along with Nursery financial aid requests. If received later it will be evaluated as long as there are funds remaining for Financial Aid.
